Brief description of your campaign – include the names of any consultants or campaign managers you will use, funds you have raised to date, and how much to expect to have to raise to win. *

I am a very strange politician, I neither solicit or spend money on my campaigns. With 1.4 million constituents, 800,000 of whom are voters, I would need to raise \$250,000 in order to run a traditional campaign with mailers and campaign offices. As a result, I depend on getting endorsements from every group with a mailing list of more than 200, like the labor councils and environmental groups and doing well in the press endorsements. Since I retired from the practice of law ten years ago, I work at my AC Transit job full time. I am also a nationally and internationally known expert on zero emission buses, and when I speak, that becomes clear. It seems unusual, but I have won six times that way, five of them contested.

Brief description of your history of involvement with and support for the Democratic Party and its candidates and ballot measure positions – include Democratic clubs/organizations to which you belong or which you have supported financially *

My first campaign was working for Jack Kennedy in 1960 (I was only 13). I have worked on virtually every Democratic campaign since then in a variety of roles from precinct walker to campaign manager. When John Laird (who I knew from college) was running against Bakersley for state senate, I took two weeks off, went down and slept on my dad's couch and worked on his campaign. I was the General Counsel for the Northern Alameda County United Democratic campaign for 16 years, one of those years I sued the registrar four times in one week and won each of the suits. I have participated in numerous initiative campaigns at both the state and local level and have served as co-chair of each of AC Transit's parcel tax campaigns, including the one in 2016. I have also worked on every transportation sales tax in Alameda and Contra Costa counties for the last 30 years. This November I am also working on the fight to save AB 5, working against Prop. 22, Assemblyman Bonta's bill against cash bail, Prop. 25 and Schools and Communities First, Prop. 15.

There are 19 Democratic Clubs in my District and I occasionally attend each of them. I have been a member of MGO (the Metropolitan greater Oakland Democratic Club) for over 40 years and attend it regularly. I have been a member of the John George Democratic Club and the Wellstone Democratic Renewal Club since each was founded and attend them regularly. I have been a member of Alameda County Democratic Lawyers Club for over 35 years. It has been more or less active over the years, but I attend when it has meetings. The City of Alameda Democratic Club meetings now conflict with AC Transit Board meetings, but I attend their holiday party at the Pasta Pelican every year and go to their fund raisers. I attend the East Bay Stonewall Democratic Club, the Hayward Area Democratic Club and El Cerrito Democratic Club regularly.

Albany prides itself on its waterfront, public schools, small town feel in a large metro area, local shopping and restaurant scene, and our city and its bodies are often debating how to make our policies and our modest city budget meet the diverse needs of our community and the needs of the region and beyond. Please provide a brief description of any impacts you have already had on the city of Albany and its residents and how, if elected, you see yourself balancing the needs of Albany with the needs of the greater region. *

AC Transit provides major transit service to Albany, both local and TransBay. One of our major routes, the 72 series, runs through the middle of Albany. It was our first "Rapid" route and is being considered for "full blown" BRT (Bus Rapid Transit).

i worked with Steve Newhouse, one of AC's planners, in the development of our first bus stop "parklet" on Solano in Albany -- a very successful re-purposing of some bus stop space into outdoor space for the adjacent eating establishments -- this even before the pandemic.

AC Transit has partnered on some housing developments on San Pablo.
